The amount budgeted for this project is \$43,060.00 for drainage work and \$124,147.05 for road work for a grand total of \$167,207.05. Based on the low bid amount the County anticipates an under run on both road and drainage work for this project.

The award will be to the low bidder Total Commitment, LLC with a low bid amount of \$104,309.12. The bids received were as follows:


