The intent of this letter is to inform Comdata Corporation and Transmontaigne Product Services, Inc., that the Council will hereby renew its current contract for retail fuel card and related services according to the terms set forth in Section VI of said contract (# 050720-CCG-FC). Based on the language within Section VI, the contract is renewed for a period of one year, from September 1, 2009 until August 31, 2010. All the terms and conditions of the current contract shall apply during the renewal period, therefore Comdata and Transmontaigne must continue to perform all services under the contract as they have unless and until any amendments to performance obligations are mutually agreed upon by the parties.
