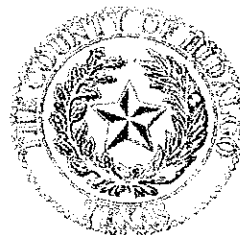
Hidalgo County Pct. 1 is requesting approval of The 5125 Company as the lowest bid for the City of Elsa Demolition and Clearance project.
