**INTERLOCAL AGREEMENT  
BETWEEN  
HIDALGO COUNTY HIGH INTENSITY DRUG TRAFFICKING AREA TASK FORCE  
AND McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT**

WHEREAS, the **HIDALGO COUNTY HIDTA TASK FORCE** and the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** are located in close proximity and have law enforcement, crime prevention and close government ties; and

WHEREAS, the **HIDALGO COUNTY HIDTA TASK FORCE** and the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** have heretofore entered into an agreement providing for the exchange of governmental services relating to the **HIDALGO COUNTY HIDTA TASK FORCE**; and

WHEREAS, the **HIDALGO COUNTY HIDTA TASK FORCE** has certain surplus equipment and the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** has a need for such surplus equipment which can be utilized in providing the service of crime prevention and law enforcement in and for the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** and in relationship to the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** contribution to the **HIDALGO COUNTY HIDTA TASK FORCE**.

NOW, THEREFORE, in consideration of the foregoing and the transfer certain surplus equipment, the **HIDALGO COUNTY HIDTA TASK FORCE** and the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** hereby agree as follows:

1. The **HIDALGO COUNTY HIDTA TASK FORCE** will permanently transfer to the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** certain surplus equipment owned by the **HIDALGO COUNTY HIDTA TASK FORCE** which is designated as

Such surplus equipment is being permanently transferred in "as-is" condition and the **HIDALGO COUNTY HIDTA TASK FORCE** makes no warranty in any manner as to the fitness of the equipment for any purpose.

2. Such equipment is to be delivered to the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** and shall be solely used for "law enforcement purposes" by the **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** as set forth under **THE STATE OF TEXAS CODE OF CRIMINAL PROCEDURE, CHAPTER 59.**
3. The **McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT** shall solely be responsible for all expenditures and requirements of said equipment as set forth under **THE STATE OF TEXAS CODE OF CRIMINAL PROCEDURE, CHAPETER 59.**
