The amount budgeted for High Point is \$0.00 for drainage work and \$121,186.80 for road work for a grand total of \$121,186.80. Based on the low bid amounts, the County anticipates an under run for roadwork.

The award will be to the low bidder Total Commitment, LLC with a low bid amount of \$58,460.50 for High Point. The bids received were as follows:


