Attached please find information regarding the award of the above-referenced 3<sup>rd</sup> Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid based on the following:

Javier Hinojosa Engineering has reviewed bids and tabulations and is recommending Valley Paving Inc. of Mission, Texas as the low bidder for the above-referenced project. The amount budgeted for Hilda Subdivision No. 2 is \$62,020.00 for drainage work and \$120,000.00 for road work for a grand total of \$182,020.00. Based on the low bid amounts, the County anticipates an under run for both roadwork and drainage.

The award will be to the low bidder Valley Paving, Inc. with a low bid amount of \$100,200.10 for Hilda Subdivision No.3. The bids received were as follows:
