The proposed budget and program amendment will **increase** funding and **add** the following to the existing Street Improvement workplan: *Drainage, water/sewer and paving infrastructure to include any other appurtenances as needed to Espaniola Heights and Barcelona Heights Subdivisions to include, but not limited to, any other streets in the general vicinity.*

2007/2008-The proposed budget and program amendment will **add** the following to the existing Street Improvement workplans: *Drainage, water/sewer and paving infrastructure to include any other appurtenances as needed to Espaniola Heights and Barcelona Heights Subdivisions to include, but not limited to, any other streets in the general vicinity.*

2009-The proposed budget and program amendment will **create** a Public Facilities line item for: *The purchase of eligible items for the City Library. (Activity will be funded with Program Income.)*


Dear Ms. Luna:
