Attached please find information regarding the award of the above-referenced 3rd Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid based on the following:

- 1) Engineers Recommendation
- 2) Bidder meets all County requirements
- 3) Bid is the lowest of bids received
- 4) Cost Breakdown

R. Gutierrez Engineering, Inc. has reviewed bids and tabulations and is recommending O.G. Construction Co., LLC of Edinburg, Texas as the low bidder for the above-referenced project. The amount budgeted for Morning Sun Subdivision is \$35,340.00 for drainage work and \$70,200.00 for road work for a grand total of \$105,540.00. Based on the low bid amounts, the County does not anticipate any overruns for the contracted part of the project. The County will use force account to construct part of the drainage project (everything other than curb and gutter and concrete driveways) and pave the road. The County might transfers funds if there is a need.

The award will be to the low bidder O.G. Construction Co, Inc. with a low bid amount of \$78,145.00 for Morning Sun subdivision. The bids received were as follows:
