Attached please find information regarding the award of the above-referenced 3rd Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid based on the following:

- 1) Engineers Recommendation
- 2) Bidder meets all County requirements
- 3) Bid is the lowest of bids received
- 4) Cost Breakdown

Rodriguez Engineering has reviewed bids and tabulations and is recommending M Construction Inc. of McAllen, Texas as the low bidder for the above-referenced project. The amount budgeted for Colonia Boyce Subdivision is \$134,547.58 for road work for a total of \$134,547.58. Based on the low bid amounts, the County anticipates an underrun for this project. The low bid award will be for roadwork only as no funds were appropriated for drainage. Precinct 1 initially wanted roadwork only as they do not have any drainage problems in this subdivision.

The award will be to the low bidder M Construction Inc. with a low bid amount of \$92,657.00 for Colonia Boyce subdivision. The bids received were as follows:
