Attached please find information regarding the award of the above-referenced 3<sup>rd</sup> Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid based on the following:

Rodriguez Engineering has reviewed bids and tabulations and is recommending M Construction Inc. of McAllen, Texas as the low bidder for the above-referenced project. The amount budgeted for Mary Ann Subdivision is \$152,036.00 for road work and \$28,800.00 for drainage work for a total of \$180,836.00. Based on the low bid amounts, the County anticipates an underrun for this project.

The award will be to the low bidder M Construction Inc. with a low bid amount of \$152,253.00 for Mary Ann subdivision. The bids received were as follows:


