

ORDER CALLING SCHOOLHOUSE BOND ELECTION

WHEREAS, the Board of Trustees (the "Board") of the Sharyland Independent School District (the "District") has, among others, the power to issue bonds for the construction and renovation of school buildings in the District and the purchase of the necessary sites therefore; and

WHEREAS, no such bonds shall be issued and no taxes shall be levied to pay bonded indebtedness of said bonds unless authorized by a majority of the resident, qualified electors of the District voting at an election called for such purpose; and

WHEREAS, the Board has determined that it is necessary and convenient to call and conduct an election pursuant to Section 45.003 of the Texas Education Code and Section 41.001(a) of the Texas Election Code to obtain voter authorization to issue such bonds;

IT IS, THEREFORE, ORDERED BY THE BOARD OF TRUSTEES OF THE SHARYLAND INDEPENDENT SCHOOL DISTRICT THAT:

Section 1. Call of Election; Date; Eligible Electors; and Hours. An election (the "Election") shall be held on **Saturday, May 8, 2010**, within and throughout the territory of the District at which all resident, qualified electors of the District shall be entitled to vote. The hours during which the polling places are to be open at the Election shall be from 7:00 o'clock a.m. to 7:00 o'clock p.m.

Section 2. Polling Places; Voting Precincts. The voting precincts for the Election, the boundaries of each voting precinct, and the polling place for each voting precinct are as follows:

The said District will be divided into two election precincts for said Election and the polling place for each election precinct shall be:

Election Precinct One. This election precinct shall be comprised of the county election precincts 54, 74, 84, 88, 74, 101, 105, 125, and 129 which are located north of 2 Mile Line. The polling place for this election precinct shall be at Garza Elementary School located on Taylor Road and 5 mile Line, Mission, Texas.

Election Precinct Two. This election precinct shall be comprised of the county election precincts 38, 47, 48, 63, 83, 84, and 95 which are located south of 2 Mile Line. The polling place for this election precinct shall be located at the Shary Road Fire Sub-Station located at 1804 N. Shary Road, Mission, Texas

Section 3. Proposition. At the Election there shall be submitted to the resident, qualified electors of the District the following proposition:

SHALL THE BOARD OF TRUSTEES (THE "BOARD") OF THE SHARYLAND INDEPENDENT SCHOOL DISTRICT (THE "DISTRICT") BE AUTHORIZED TO ISSUE AND SELL AT ANY PRICE OR PRICES THE BONDS OF THE DISTRICT IN THE AMOUNT OF NINE MILLION NINE HUNDRED EIGHTY FIVE THOUSAND (\$9,985,000.00) DOLLARS FOR THE CONSTRUCTION AND EQUIPMENT OF SCHOOL BUILDINGS IN THE DISTRICT (INCLUDING THE REHABILITATION, RENOVATION, IMPROVEMENT AND REPAIR THEREOF), AND THE PURCHASE OF NECESSARY SITES THEREFOR, WHICH BONDS MAY BE ISSUED IN VARIOUS SERIES OR ISSUES, SHALL MATURE SERIALY OR OTHERWISE NOT MORE THAN 40 YEARS FROM THEIR DATE OR DATES AND BEAR INTEREST AT SUCH RATE OR RATES (FIXED, VARIABLE, FLOATING, ADJUSTABLE OR OTHERWISE) AS SHALL BE DETERMINED BY THE BOARD WITHIN ITS DISCRETION AT THE TIME OF ISSUANCE, BUT NOT TO EXCEED THE MAXIMUM RATE NOW OR HEREAFTER AUTHORIZED BY LAW; AND SHALL THE BOARD BE AUTHORIZED TO LEVY AND PLEDGE, AND CAUSE TO BE ASSESSED AND COLLECTED, ANNUAL AD VALOREM TAXES ON ALL TAXABLE PROPERTY IN THE DISTRICT SUFFICIENT, WITHOUT LIMIT AS TO RATE OR AMOUNT, TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS AS THEY BECOME DUE, ALL AS AUTHORIZED BY THE CONSTITUTION AND LAWS OF THE STATE OF TEXAS, INCLUDING PARTICULARLY (BUT NOT BY WAY OF LIMITATION) SUBCHAPTER A OF CHAPTER 45 OF THE TEXAS EDUCATION CODE, TOGETHER WITH ALL AMENDMENTS AND ADDITIONS THERETO, AND OF THE UNITED STATES OF AMERICA?

Section 4. Form of Proposition on Ballot. At Early Voting and at the Election, the proposition shall be submitted to the voters in substantially in the following form:

“Place an “X” in the square beside the statement indicating the way you wish to vote.”


Section 6. Early voting day, dates, hours, and polling place. Early voting shall commence on **Monday, April 26, 2010** and terminate on **Tuesday, May 4, 2010**. The main polling place for early voting will be at Shary Road Fire Sub-Station, 1804 N. Shary Road, Mission, Texas. Early voting shall be conducted in accordance with the Texas Election Code on the following days, dates, and hours during the early voting period:

Tuesday, May 4, 2010	-	8:00 a.m. to 6:00 p.m.

Section 7. Notice of Election. Notice of the Election shall be given in the manner prescribed by the Texas Election Code.


Section 8. Authority to Execute. The President of the Board of Trustees is authorized to execute, and the Secretary of the Board of Trustees is authorized to attest this Election Order on behalf of the Board. The President of the Board of Trustees is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.
