**MEMORANDUM OF UNDERSTANDING
BETWEEN**

**HIDALGO COUNTY HIGH INTENSITY DRUG
TRAFFICKING AREA (HIDTA) TASK FORCE**

AND

HIDALGO COUNTY CONSTABLE'S OFFICE, PRECINCT 3

WHEREAS, the **HIDALGO COUNTY HIDTA TASK FORCE** and the **HIDALGO COUNTY CONSTABLE'S OFFICE, PRECINCT 3** are located in close proximity and have law enforcement, crime prevention and close government ties; and

WHEREAS, the **HIDALGO COUNTY HIDTA TASK FORCE** and the **HIDALGO COUNTY CONSTABLE'S OFFICE, PRECINCT 3** have heretofore entered into an agreement providing for the exchange of governmental services relating to the **HIDALGO COUNTY HIDTA TASK FORCE** and


NOW, THEREFORE, to enhance cooperation among local law enforcement agencies and express their mutual commitment of depriving criminals of proceeds generated by their illegal activities, the **HIDALGO COUNTY HIDTA TASK FORCE** will provide the amount of ten thousand dollars (\$10,000.00) to the **HIDALGO COUNTY CONSTABLE'S OFFICE, PRECINCT 3**.

THEREFORE, the parties hereto agree as follows:


1. The **HIDALGO COUNTY HIDTA TASK FORCE** shall present to the **HIDALGO COUNTY CONSTABLE'S OFFICE, PRECINCT 3** the sum of ten thousand dollars (\$10,000.00).
2. The amount of ten thousand dollars (\$10,000.00) shall solely be used for law enforcement purposes by the **HIDALGO COUNTY CONSTABLE'S OFFICE, PRECINCT 3** as set forth under the Texas Code of Criminal Procedure Chapter 59.
3. The **HIDALGO COUNTY CONSTABLE'S OFFICE, PRECINCT 3** shall solely be responsible for all expenditures and requirements as set forth under the **TEXAS CODE OF CRIMINAL PROCEDURE CHAPTER 59**

This agreement becomes effective on the Date it is signed by both parties. It remains in effect unless terminated, by either party. This agreement can be terminated upon thirty (30) days written notice.


