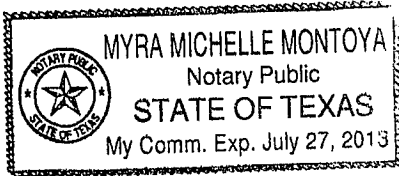
I, VICTOR VALDEZ, do hereby state that my membership in the
