Dear Ms. Serna,

Thank you for giving Consumer Credit Counseling Service of South Texas the opportunity to serve our community by providing Homeless Prevention funds for mortgage assistance to the families of Hidalgo County. This program has successfully come to a close. All the program funds were exhausted in March 2010. Fifty-one mortgages were rescued and over two hundred individuals were impacted with these homeless prevention funds.

However, as per our records, the number of applications for mortgage assistance surpassed our projection. We have over twenty eligible families facing foreclosure and at risk of becoming homeless. For this reason, I am requesting additional funds for the continuation of our work in Hidalgo helping to modify home mortgages stopping foreclosures, and assisting clients to get caught up in their mortgage arrears.

If funded, CCCS mortgage assistance will continue to provide services to clients on our current waiting list or until all funds allotted are expended within an agreed specified time.

Thank you again for the attention to this matter. Please let me know if this is an acceptable proposal. Any addition, funds toward the mortgage assistance is deeply appreciated.
