

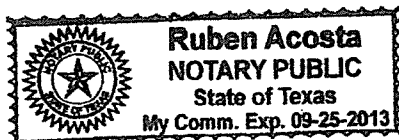

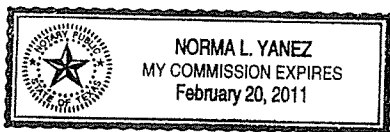

To solicit public comments from interested parties on the city's proposed budget and program amendments to its Urban County Program, Years 20 & 21 (2007 & 2008).

Mayor Pro-Tem Saucedo motioned and Councilwoman Muñoz seconded to open public hearing at 6:16 pm.

Fernando Flores informed Council this public hearing was required to comply with Urban County Program guidelines pertaining to any amendments on program funding. He stated the proposed amendment would allow the transfer of funds from the Water/Sewer line item for years 2007 & 2008 into the same line item for year 2010. The total amount to be transferred from both years is about \$106,012.98. The funds will be utilized to replace a clay sewer line in alley on Fordyce between Main and 8th streets. Citizen Dahlia Jimenez asked how this particular project was chosen. Mr. Flores responded that this project was already in the plans and environmental have been done. At this time, City manager stated there were other clay sewer lines that needed to be replaced but the city will replace them as funds become available. Right now the city will work on those that urgently need to be replaced. As soon as amendment is approved, Urban County will begin on bidding out the project through their procurement process. There being no further comments. Mayor Pro-Tem Saucedo motioned and Councilman Garza seconded to close public hearing. The motion carried unanimously and public hearing was closed at 6:26 pm.
