


## Summary:

This position performs a wide range of complex, confidential and sensitive executive level administrative duties for the Sheriff.

## Distinguishing Characteristics of the Class:

Positions in this class, under general supervision, identify issues, conduct research and develop solutions, options and alternatives for a variety of sensitive, confidential or complex administrative, managerial or operational problems; prepare a variety of reports and correspondence; serve as liaison to the operating bureaus or divisions of the Sheriff's Office; implement and manage a variety of special projects and activities; The work requires knowledge of personnel practices, activities, rules and procedures and of management techniques. Guidelines are available in Sheriff's Office policies and procedures and other materials. However, considerable judgment is used to determine the best way to study and prepare recommendations on complex, confidential and sensitive administrative management and operational problems and in solving the more complex and difficult problems. This class differs from the Administrative Assistant in that the Executive Assistant position provides administrative support to the head of an office or department. Personal contact is primarily with representatives of other departments and agencies, bureau level commanders and division level captains, the staff of elected officials and with the public for coordinating inter-divisional work efforts, researching problems and providing information on the programs and activities of the Sheriff's Office.

## Examples of Work:

- Serves as primary professional staff support for the Sheriff; conducts research, develops options or solutions and makes recommendations on a variety of management and administrative problems and concerns; and participates in management level decision making regarding policies, programs and actions.
- Serves as liaison between the executive and the various bureau commanders division captains; provides direction on and monitors assignments given to bureau commanders and/or division captains; manages major inter-divisional projects or studies.

- Reviews all correspondence and requests for information directed to the executive; distributes correspondence to appropriate bureaus and divisions for response; tracks and follows up on correspondence assignments; and personally prepares memos, correspondence and reports as necessary.
- May act as Sheriff's Office representative to other departments, federal, state and local agencies, and with the public, the County Judge's Office and with Commissioner's Court's staff; negotiates and resolves administrative policies and issues; attends meetings and makes presentations as necessary; oversees preparation of news releases, announcements and other types of information to the media; and interprets and explains Sheriff's Office policies, procedures and actions.
- May participate in or monitor personnel activities such as interviewing, selection, training programs and performance evaluation.
- Performs other related duties of a comparable level/type as assigned.
