Ms. Julie:
 I think we have a solution for your offer to re-quote under TASB contract (in effect at the same time as original TXMAS purchase) with John Deere. The following would need to occur inasmuch as original purchase order issued (614087) and liquidated/paid:

- 1) Purchasing would place an agenda item on the next Commissioners Court meeting to request approval of a "correction" to the original purchase order to reflect the TASB contract number (in place at the time of the original purchase);
- 2) Process a Corrected PO;
- 3) Forward to John Deere;

Additionally, John Deere will issue a refund to Hidalgo County for \$224.68 plus applicable interest (negotiable). We hope that this plan of action meets with your approval so as to finally settle this matter.

Marty,
I spoke with Dan on Friday afternoon regarding the tractor and based on this conversation and his willingness to keep the tractor, I have redone the pricing based on the TASB contract at the time. Checking into the contract I found that the TASB contract actually gave a 1% higher discount, resulting in a lower price of \$16,626.32.

If changing the contract to TASB is feasible we'd need a modified PO with the correct contract noted. Please let me know!
