AFFIDAVIT FOR PAYMENT OF MEMBERSHIP DUES**

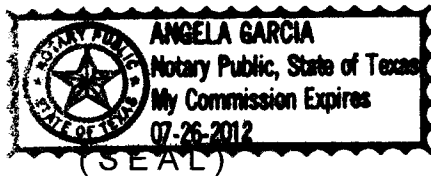
