

CERTIFICATE OF THE COUNTY JUDGE OF HIDALGO COUNTY, TEXAS
**(Education Revenue Bonds (IDEA Public Schools) Series 2010A
Taxable Education Revenue Bonds (IDEA Public Schools) Series 2010B)**

The undersigned County Judge of Hidalgo County, Texas, (the "County") hereby certifies with respect to the issuance by the San Juan Higher Education Finance Corporation (the "Corporation"), of its Education Revenue Bonds (IDEA Public Schools) Series 2010A and Taxable Education Revenue Bonds (IDEA Public Schools) Series 2010B (collectively, the "Bonds"), that:

1. This certificate is based upon the CERTIFICATE OF PUBLIC HEARING OFFICER REGARDING PUBLIC HEARING attached hereto as **Exhibit A** relating to the public hearing conducted on the date indicated in the Affidavit of Publication attached to such Minutes of Public Hearing by the duly appointed hearing officer of the Corporation in accordance with the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended; and

Solely for purposes of the approval requirements of the aforesaid Section 147(f) of the Code, and for no other purpose, in my capacity as County Judge, I hereby approve the Bonds the facilities to be financed with the proceeds of the Bonds, and hereby ratify and approve all actions taken by or on behalf of the County with respect to the appointment of the Hearing Officer, the publication of the Notice of the Public Hearing as reflected in the Affidavit of Publication attached as **Exhibit A** to the attached Certificate of Public Hearing Officer, and the conducting of such Public Hearing.

THIS APPROVAL SHALL NOT BE CONSTRUED AS (1) A REPRESENTATION OR WARRANTY BY THE COUNTY, THE COUNTY JUDGE OF THE COUNTY, THE STATE OF TEXAS OR ANY OTHER AGENCY, INSTRUMENTALITY OR POLITICAL SUBDIVISION OF THE STATE OF TEXAS THAT THE BONDS WILL BE PAID OR THAT ANY OBLIGATIONS ASSUMED BY ANY OF THE PARTIES UNDER THE INSTRUMENTS DELIVERED IN CONNECTION WITH THE BONDS WILL IN FACT BE PERFORMED; (2) A PLEDGE OF THE FAITH AND CREDIT OF THE COUNTY OR THE STATE OF TEXAS OR ANY AGENCY, INSTRUMENTALITY OR POLITICAL SUBDIVISION OF THE STATE OF TEXAS OR THE COUNTY; OR (3) A REPRESENTATION OR WARRANTY BY THE COUNTY CONCERNING THE VALIDITY OF THE CORPORATE EXISTENCE OF THE CORPORATION OR THE VALIDITY OF THE BONDS.

Notice is hereby given of a public hearing to be held on behalf of the San Juan Higher Education Finance Authority on October 20, 2010, at 5:00 p.m., at 505 Ayellita Drive, Suite 9, Weslaco, Texas 78596, with respect to the captioned Series 2010A Bonds and Series 2010B Bonds to be issued in an aggregate principal amount not to exceed \$40,000,000 by the San Juan Higher Education Finance Authority (the "Corporation"). The proceeds of the Bonds will be loaned to IDEA Public Schools, a Texas nonprofit corporation (the "Borrower"), for the following purposes: (a) financing and reimbursing certain costs for the construction, renovation and/or equipment of educational facilities, located at 327 E. SH 495, Alamo, Texas 78516; (b) financing and reimbursing certain costs for the construction, renovation and/or equipment of educational facilities, located at 600 E. Las Milpas Rd., Pharr, Texas 78577; (c) financing and reimbursing certain costs for the construction, renovation and/or equipment of educational facilities, located at 14001 N. Rooth Rd., Edinburg, Texas 78541; (d) financing and reimbursing certain costs for the construction, renovation and/or equipment of educational facilities, located at 400 North Virgen de San Juan Blvd., San Juan, Texas 78589; (e) financing and reimbursing certain costs for the acquisition, construction, renovation and/or equipment of real property and educational facilities, located at the northwest, southwest and southeast corners of Cullen Street and Roegiers Road in Edinburg, Texas; (f) financing and reimbursing certain costs for the acquisition, construction, renovation and/or equipment of real property and educational facilities, located at 2931 E. Sugarcane Drive, Weslaco, Texas 78596; (g) funding a debt service reserve fund or the purchase of a Reserve Fund Surety Policy and capitalized interest; and (h) paying a portion of the costs of issuance of the Bonds. The Project will be owned and operated by the Borrower. The Bonds are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower.

The public hearing will be conducted by Wyatt J. Truscheit or his designee (the Hearing Officer). All interested persons are invited to attend such public hearing to express their views with respect to the above-described project and the Bonds. Any interested persons unable to attend the hearing may submit their views in writing to the Hearing Officer prior to the date scheduled for the hearing at fax number (713) 238-5040.
