AGREED JUDGMENT

ON THIS date, came to be considered the above referenced cause wherein the State of Texas alleged that it had seized **ONE (1) 2007 PROGRESSIVE TRAILER, VIN #1P9GE44247P587829; ONE (1) 1997 FREIGHTLINER, VIN #1FUWHLBB1VL824459; and TWENTY-TWO (22) MISCELLANEOUS WOODEN FURNITURE AND TOY SETS; SIX (6) 4" X 8" PICNIC TABLES; THREE (3) CHILDREN'S PICNIC TABLES; ONE (1) RUSTIC WOOD SWINGS; ONE (1) BENCH; FOUR (4) SWING CHAIN BENCH; THREE (3) TABLE BENCH COMBOS; AND FOUR (4) CHILDREN'S SEE-SAWS,** and came the State of Texas by and through her Criminal District Attorney in and for Hidalgo County, Texas, and Respondent **RITA MARTINEZ dba R TRM EXPRESS; and MANUEL RIGOBERTO HERNANDEZ aka MANUEL RIGOBERTO RUTIAGA HERNANDEZ, UNITED STATES MARSHAL #75472279** , having filed an answer by and through his attorney of record, Honorable **SERGIO VALDEZ.**

The Plaintiff and Respondent **RITA MARTINEZ dba R TRM EXPRESS; and MANUEL RIGOBERTO HERNANDEZ aka MANUEL RIGOBERTO RUTIAGA HERNANDEZ, UNITED STATES MARSHAL #75472279** announced to the Court that the parties hereto agree that in lieu of a contested hearing an Agreed Judgment should be entered herein. The Court, after considering the pleading presented and that all parties had endorsed this Agreed Judgment, finds that the **ONE (1) 1997 FREIGHTLINER, VIN #1FUWHLBB1VL824459,** made the subject of this suit, shall be returned to Respondent **RITA MARTINEZ dba R TRM EXPRESS; and MANUEL RIGOBERTO HERNANDEZ aka MANUEL RIGOBERTO RUTIAGA HERNANDEZ, UNITED STATES MARSHAL #75472279** , by and through his attorney of record, Honorable **SERGIO VALDEZ,** and **ONE (1) 2007 PROGRESSIVE TRAILER, VIN #1P9GE44247P587829; and TWENTY-TWO (22) MISCELLANEOUS WOODEN FURNITURE AND TOY SETS; SIX (6) 4" X 8" PICNIC TABLES; THREE (3) CHILDREN'S PICNIC TABLES; ONE (1) RUSTIC WOOD SWINGS; ONE (1) BENCH; FOUR (4) SWING CHAIN BENCH; THREE (3) TABLE BENCH COMBOS; AND FOUR (4) CHILDREN'S SEE-SAWS,** shall be forfeited to the HIDALGO COUNTY DISTRICT ATTORNEY'S OFFICE and the **HIDALGO COUNTY CONSTABLE PRECINCT 4.**

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the **ONE (1) 2007 PROGRESSIVE TRAILER, VIN #1P9GE44247P587829; ONE (1) 1997 FREIGHTLINER, VIN #1FUWHLBB1VL824459; and TWENTY-TWO (22) MISCELLANEOUS WOODEN FURNITURE AND TOY SETS; SIX (6) 4" X 8" PICNIC TABLES; THREE (3) CHILDREN'S PICNIC TABLES; ONE (1) RUSTIC WOOD SWINGS; ONE (1) BENCH; FOUR (4) SWING CHAIN BENCH; THREE (3) TABLE BENCH COMBOS; AND FOUR (4) CHILDREN'S SEE-SAWS,** IN UNITED STATES, made the subject of this suit and identified in the Plaintiff's Original Petition and Notice of Seizure and Intended Forfeiture filed herein, be

and the same are hereby disposed in the following manner pursuant to the agreement between the parties:

- (a) **ONE (1) 2007 PROGRESSIVE TRAILER, VIN #1P9GE44247P587829; and TWENTY-TWO (22) MISCELLANEOUS WOODEN FURNITURE AND TOY SETS; SIX (6) 4" X 8" PICNIC TABLES; THREE (3) CHILDREN'S PICNIC TABLES; ONE (1) RUSTIC WOOD SWINGS; ONE (1) BENCH; FOUR (4) SWING CHAIN BENCH; THREE (3) TABLE BENCH COMBOS; AND FOUR (4) CHILDREN'S SEE-SAWS, is/are forfeited to the HIDALGO COUNTY CRIMINAL DISTRICT ATTORNEY and the HIDALGO COUNTY CONSTABLE PRECINCT 4, pursuant to the parties' local agreement;**
- (b) **ONE (1) 1997 FREIGHTLINER, VIN #1FUWHLBB1VL824459, shall be returned to Respondent RITA MARTINEZ dba R TRM EXPRESS; and MANUEL RIGOBERTO HERNANDEZ aka MANUEL RIGOBERTO RUTIAGA HERNANDEZ, UNITED STATES MARSHAL #75472279, by and through his attorney of record, Honorable SERGIO VALDEZ;**

IT IS FURTHER ORDERED that the **ONE (1) 2007 PROGRESSIVE TRAILER, VIN #1P9GE44247P587829;** hereinafter referred to as the "subject vehicle"; the subject of this suit, be awarded to the **HIDALGO COUNTY CONSTABLE PRECINCT 4,** to be used for Law Enforcement purposes.

IT IS FURTHER ORDERED that the "subject vehicle" be released INSTANTER to the **HIDALGO COUNTY CONSTABLE PRECINCT 4,** and the State Department of Highway and Public Transportation is ordered to issue valid certificate of title to **HIDALGO COUNTY CONSTABLE PRECINCT 4** for the "subject vehicle".

IT IS FURTHER ORDERED that in the event the "subject vehicle" is to be sold at auction by the **HIDALGO COUNTY CONSTABLE PRECINCT 4** pursuant to the Texas Transportation Code and/or the Texas Code of Criminal Procedure, the State Department of Highway and Public Transportation is ordered to issue valid certificate of title to the PURCHASER of the "subject vehicle" subsequent to the sale at auction.

IT IS ALSO FURTHER ORDERED, ADJUDGED AND DECREED that the Court Costs be paid by the **HIDALGO COUNTY CONSTABLE PRECINCT 4.**

All relief not expressly granted is hereby denied.
