**INTERLOCAL AGREEMENT
BETWEEN
HIDALGO COUNTY HIGH INTENSITY DRUG
TRAFFICKING AREA (HIDTA) TASK FORCE
AND
McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT**

WHEREAS, the HIDALGO COUNTY HIDTA TASK FORCE and the McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT are located in close proximity and have law enforcement, crime prevention and close government ties; and

WHEREAS, the HIDALGO COUNTY HIDTA TASK FORCE and the McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT have heretofore entered into an agreement providing for the exchange of governmental services relating to the HIDALGO COUNTY HIDTA TASK FORCE and

WHEREAS, the McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT has and will continue to assist the HIDALGO COUNTY HIDTA TASK FORCE during law-enforcement operations.

THEREFORE, the parties hereto agree as follows:


1. The McALLEN INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT will provide K9 narcotic detecting services when and if possible during law-enforcement operations conducted by the Hidalgo County HIDTA Task Force whenever canine services are required.

This agreement becomes effective on the Date it is signed by both parties. It remains in effect unless terminated, by either party. This agreement can be terminated upon thirty (30) days written notice.
