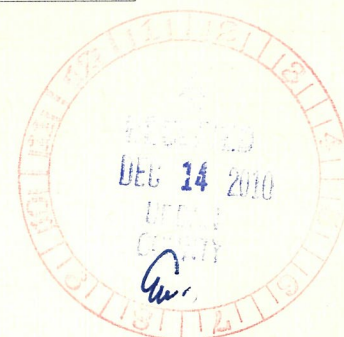

\_\_\_\_\_ **SECTION 5.** All renewal fees shall be paid directly by an alarm company... All permits shall expire one full year after date of issuance of such permit.

\_\_\_\_\_ **SECTION 11. ALARM RESPONSE LIABILITY.** The Pharr Police Dept. of City of Pharr Texas & the individual members of the Board of Commissioners of the City of Pharr and the Mayor of the City Pharr shall not be held liable/accountable in damages to the premises subject of the alarm as result of any act or acts of the Pharr Police Dept. in response to a alarm.

\_\_\_\_\_ **SECTION 12. FALSE ALARMS, FALSE ALARM LIMITATIONS, and FALSE RESPONSE FEES.** False alarms responded to by the Police Department shall be limited to three (3) per calendar month, per alarm module or Department notification by an alarm company. False alarms in excess of 3 per calendar month will require the payment by the alarm company (permittee) to the Police department on the following schedule:

4<sup>TH</sup> FALSE ALARM - \$50.00  
5<sup>TH</sup> FALSE ALARM - \$75.00  
6<sup>TH</sup> FALSE ALARM - \$100.00

**\*\*\*FALSE ALARMS IN EXCESS OF 6 PER CALENDAR MONTH WILL INCUR AN ADDITIONAL \$10.00 FEE PER ACTIVATION**
