AMENDMENT TO  
INTER-LOCAL COOPERATION AGREEMENT  
FOR TAX ASSESSMENT AND COLLECTION

This AMENDMENT TO INTER-LOCAL COOPERATION AGREEMENT FOR TAX ASSESSMENT AND COLLECTION ("Amendment"), dated June 1st, 2010, is made between the School District of Valley View, hereinafter referred to as "SCHOOL DISTRICT," and Hidalgo County, hereinafter referred to as "COUNTY," pursuant to the provisions of the Texas Interlocal Cooperation Act, as follows:

WHEREAS, on or about May 10th, 2005, COUNTY entered into an Interlocal Cooperation Agreement "(Interlocal") with SCHOOL DISTRICT for the consolidation of the assessment and collection of property taxes; and


WHEREAS, COUNTY and SCHOOL DISTRICT now desire to amend the Interlocal as hereinafter provided.

NOW, THEREFORE, for and in consideration of TEN and NO/100 Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, COUNTY and SCHOOL DISTRICT hereby agree to the following amendments to the Interlocal:


1. Section VI of the Interlocal is amended to read as follows:
  - "1. SCHOOL DISTRICT hereby agrees to pay and COUNTY agrees to accept a fee of \$ 23,100.00 of all current and delinquent base taxes collected from June 1 through May 31. For subsequent years, after reviewing actual collection costs, COUNTY will submit to SCHOOL DISTRICT, prior to May 1, the fee for the following year. In no event will the cost increase by more than five percent (5%) per year. SCHOOL DISTRICT will have until June 1 to accept the recommended fee.
  2. COUNTY will be paid by deducting the fee at the rate of \$ 1,925.00 from Monthly collections and will submit Monthly Collections Reports."
2. Except as modified herein, all terms and conditions of the Interlocal, as amended, remain in full force and effect.
