**AMENDMENT TO SERVICE CONTRACT
(E-10-322-08-24)**

This **AMENDMENT** to the **EXTENDED CONTRACT** for **Impoundment and Quarantine of Small Animals** dated September 30, 2010, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **PALM VALLEY ANIMAL CENTER** (“Company”) is entered into between the parties effective this **22nd** day of **February, 2011**.

WHEREAS, Company and County entered into a Contract dated **September 30, 2008**, with the “**initial contract term**” of two (2) years commencing, **September 30, 2008**, expiring **September 30, 2010**, thereafter a “renewal term” of an additional one (1) year term commencing, **September 30, 2010**, expiring **September 30, 2011**, in which the Company agreed to provide services for the purposes of “**Impoundment and Quarantine of Small Animals**” for **Hidalgo County**(the “Contract”);

WHEREAS, Company is the sole provider of Impoundment and Quarantine of Small Animals in Hidalgo County;

WHEREAS, the parties desire to amend the Contract as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

I. Paragraph 4 of the Contract is deleted in its entirety and replaced with the following in lieu thereof the existing written paragraph:

4. As consideration for performing the services enumerated hereinafter, County agrees to pay Contractor a sum equal to **\$400,000.00** for the first twenty four (24) month period during the term hereof. Contractor shall be paid an amount equal to the prorata portion of the Contract performed by the Contractor during the prior month on the first day of each month that the services have been performed by Contractor for County. This fee shall cover all services rendered by Contractor under this Agreement for the first twenty-four (24) month period. As consideration for performing the services for the renewal term, County agrees to pay Contractor a sum equal to **\$ 33,333.34 (per month)** for

the first six (6) months of the extended twelve (12) month period of the renewal term and \$41,666.66 (per month) for the remaining six (6) month period of the renewal term. This fee shall cover all services rendered by Contractor under this Agreement for the renewal term.

2. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms and provisions of the Contract as amended.
