Attached please find information regarding the award of the above-referenced 3<sup>rd</sup> Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid based on the following:

- 1) Engineers Recommendation
- 2) Bidder meets all County requirements
- 3) Bid is the lowest of bids received
- 4) Cost Breakdown

TEDSI Infrastructure Group, Inc. has reviewed bids and tabulations and is recommending Saenz Utility Contractor Ltd Edcouch, Texas as the low bidder for the above-referenced project. The amount budgeted for roadwork is \$78,876.17 and the amount budgeted for drainage is \$10,800.00 for a total amount of \$89,676.17

Based on the low bid amounts, roadwork cost will have an overrun. The overrun amount for roadwork (\$7,958.92) will be covered by Precinct 1's Road & Bridge funds. Drainage cost has sufficient funding. The project will be within the total roadwork allowable of \$500K/mile. (See Attached Spreadsheet)

The award will be to the low bidder Saenz Utility Contractors Ltd. with a low bid amount of \$105,546.40. The bids received were as follows:
