Other individuals may then be added as members from the same organization for an additional \$100 per person. All benefits of membership are available to each individual who is identified as a member by the organization.

NOTE: Organizational Members are eligible to use the member discount rate for a total of three (3) conference registrations, regardless of whether the individuals being registered are the same as those the organization has listed as members. All other benefits, however, apply only to the designated primary contact and any additional paid members in that organization.

FAMILY / VOLUNTEER / RETIRED MEMBERSHIP

This membership category is open to family members who serve as guardians for an individual, to individuals working as guardians without remuneration, or for those who are retired from providing professional guardianship services, but want to continue to access the NGA membership benefits. Annual dues are \$50. Note: Members in these categories are not listed in "Find A Guardian" on the website, but they are included in the Membership Directory and receive all other membership benefits.
