NARRATIVE:-

Contact was made with Juan Manuel Carranza (DOB 9-29-56) (reporting party) who said:

  - he removed the keys on ignition and left to the office along with the other workers.
  - they left the tractors at location / work area because they were cutting the grass on the canal.
  - he does not suspect of anyone or any information on who might have taken the tractor.
  - the only one that was given consent and authorization to drive tractor was himself.
  - Friday, August 6, 2010 in the afternoon was the last time, and place he saw tractor at location.
  - he wishes to file a report.

- he witnessed Zoraido Hernandez park and leave the tractor at location on Friday, (8-6-2010)
  - they always leave the tractors at location because they are working on cutting the grass on canal.
