As per our conversation, I am emailing you to confirm that two issues that you requested information on:

- 1) Fiscal Impact of Grantee - There would be no fiscal responsibility on the part of the grantee, as no matching funds are required for this program.
- 2) Expenditures/Requirements - Funding is based on the number of retailers within the applicants jurisdiction. You are required to conduct judicial education to your court, retailer education, compliance inspections, and controlled buys. You will report educational and financial activities on a quarterly basis, and enforcement activities on a monthly basis. Grant funds can be used for salary and incidental needs to complete these required activities.
