The 2011 Truth-in-Taxation software (TNT2011) is used for setting the 2011 tax rates. The program will be available once the Texas Comptroller of Public Accounts has released their final Worksheets for the calculation of the Effective and Rollback Tax Rates. We estimate that this will occur in July, 2011. In May, an early version of the program will be available based on last year's calculations. The calculations for TNT2011 will be updated as needed for the calculation of 2011 tax rates, up until December 31, 2011.
