Attached please find information regarding the award of the above-referenced 3<sup>rd</sup> Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid on the following

- 1). Engineers Recommendation
- 2). Bidder meets all County requirements
- 3). Bid is the lowest of bids received
- 4). Cost Breakdown

Javier Hinojosa Engineering/consulting Engineers has reviewed bids and tabulations and is recommending Saenz Utility Contractors, Ltd of Edcouch, Texas as the low bidder for the above-referenced project. The amount budgeted for roads is \$489,497.50 and budgeted for drainage is \$161,250.00 for a total amount of \$650,747.50. Based on the low bid amounts, road work will have an underrun and drainage will have an overrun. The overrun amount for drainage which is (\$31,244.50) will be covered by roadwork underrun. The total roadwork allowable at \$500K/mile is \$587,140.00 (\$94.70/ft @500K/mi) X 6200 linear feet.

The award will be to the low bidder Saenz Utility Contractors, Ltd with a low bid amount of \$493,464.40.


