
RE: Budget & Program Amendment for San Juan Public Library Fund

The following is the proposed Budget & Program amendment for your consideration:

The CDBG allocated funds in the amount of **\$100,000.00** from Street Improvements year 23 (2010) from the existing work plan and add a NEIGHBORHOOD FACILITIES activity for the City of San Juan Public Library. Funds will be utilized to purchase furniture (desks, seating, tables, cabinets, computer tables/carrels) and/or any related equipment.
