
RESOLUTION NO. 2009-8

- WHEREAS,** The City of Peñitas was legally incorporated as a General Law City under the authority of the State of Texas Constitution, and
- WHEREAS,** The City of Peñitas has made a determination to improve the quality of life for its residents in City of Peñitas by authorizing the creation of a City library, and
- WHEREAS,** The City will designate the Dr. Roberto Zamora Building as the site for such Library and will fund this operations from its general fund budget, and
- WHEREAS,** The City will created a Library Board of Directors and will appoint members to this board from its Citizens that reside within its city limits, and
- WHEREAS,** The City of Peñitas Board of Alderman authorize the City administrator to obtain any supplies, books, grants or funding that might be available for the start, operation, maintenance and equipment for this library endeavor.

NOW THEREFORE BE IT RESOLVED BY THE PEÑITAS BOARD OF ALDERMEN THAT:

1. The Peñitas Board of Aldermen hereby authorize the designation of this site for the creation of a City library, create a City Library board, amend the city budget to provide for funds for operations, staff, and be administered by the City of Peñitas Board of Alderman.

READ, PASSED AND APPROVED BY THE BOARD OF ALDERMEN OF THE CITY OF PEÑITAS, HIDALGO COUNTY, TEXAS ON THIS THE 13th DAY OF MAY AT A REGULARLY SCHEDULED MEETING AT WHICH A QUORUM WAS PRESENT.
