The proposed budget and Program Amendment for FY 24 (2011) will reduce funding and delete projects from the proposed work plans for cities' and Precinct's. The listed activity line items will be affected for each of the specified City or Precinct and the UCP Common Funds and UCP Program Administration. **The total CDBG budget reduction amount is \$1,500,887.00**, therefore the FY 24 (2011) total **CDBG Allocation** is **\$7,639,061.00**.

The total HOME budget reduction amount is \$351,762.00 for FY 24 (2011) therefore, the total **HOME Allocation** is **\$2,621,620.00**.

The ESG budget reduction amount is \$440.00 for FY 24 (2011) therefore, the total **ESG Allocation** is **\$ 370,298.00**.

  - b. Notify the employer in writing of his or her conviction for a violation of a criminal drug statute occurring in the workplace no later than five calendar days after such conviction;
5. Notifying the agency in writing, within ten calendar days after receiving notice under subparagraph 4(b) from an employee or otherwise receiving actual notice of such conviction. Employers of convicted employees must provide notice, including position title, to every grant officer or other designee on whose grant activity the convicted employee was working, unless the Federal agency has designated a central point for the receipt of such notices. Notice shall include the identification number(s) of each affected grant;
6. Taking one of the following actions, within 30 calendar days of receiving notice under subparagraph 4(b), with respect to any employee who is so convicted -
  - a. Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or
  - b. Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal, State, or local health, law enforcement, or other appropriate agency;
7. Making a good faith effort to continue to maintain a drug-free workplace through implementation of paragraphs 1, 2, 3, 4, 5 and 6.
