

**AMENDMENT TO EXHIBIT "A"
PERFORMANCE STATEMENT**

Texas Rio Grande Legal Aid, Inc., having been certified as a non-profit, has been allocated Homeless Prevention and Rapid Re-housing Program (HPRP) Funds. The non-profit shall carry out the following activities identified in its HPRP Funds Application:

OPERATIONS UNDER HOUSING

Texas Rio Grande Legal Aid, Inc. will utilize HPRP Funds for the provision of services to persons/families that are at risk of being homeless. Texas Rio Grande Legal Aid, Inc. was granted funds in the amount of \$328,328.10 for Homeless Prevention. The assistance to the families will be Housing Relocation & Stabilization Services, Data Collections, and Administration.

The subrecipient agreement was entered between Texas Rio Grande Legal Aid, Inc. and the Hidalgo County – Urban County Program on September 29, 2009 and will terminate on July 20, 2012.

The Hidalgo County Urban County Program is requesting that the contract with Texas Rio Grande Legal Aid, Inc. be reduced by \$71,191.00 to be able to meet the threshold by the July 20, 2012 deadline. This amount will be re-allocated to other HPRP non-profit agencies.

The new grant amount for Texas Rio Grande Legal Aid, Inc. will be \$ 257,137.10.

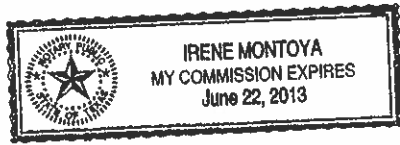
