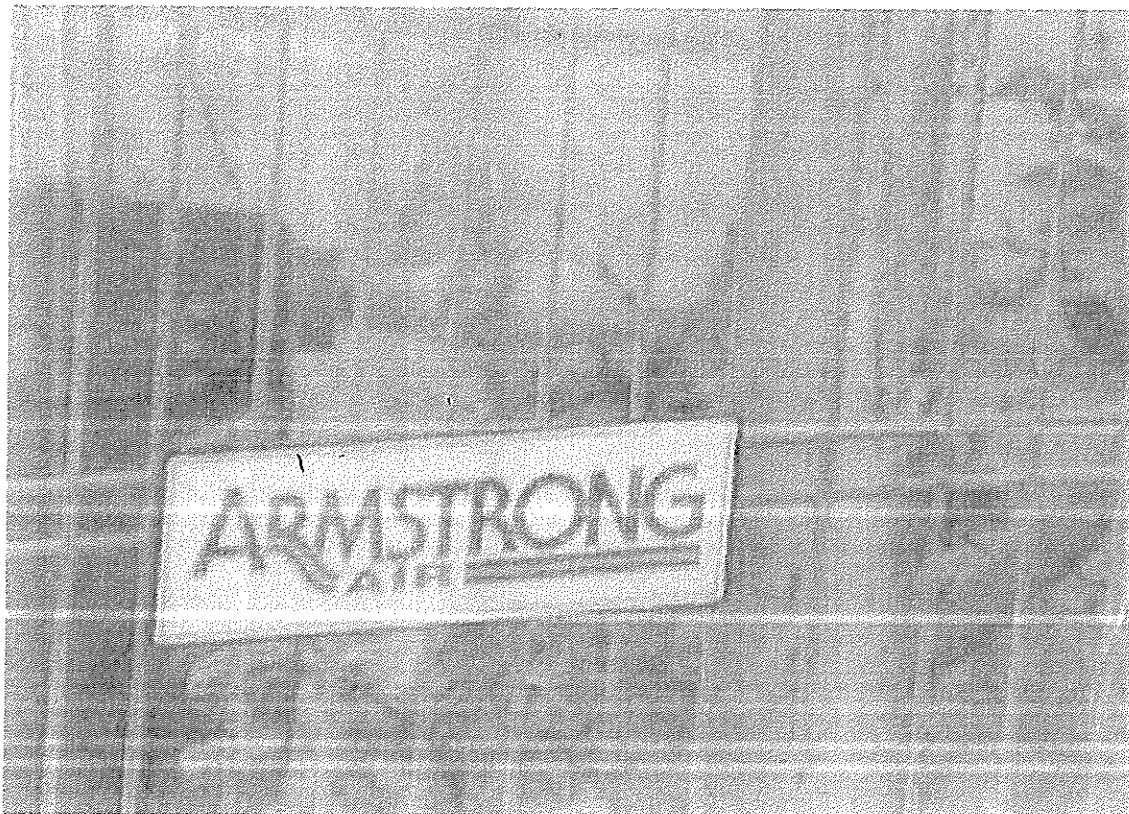
0802051530 Pct. # 3 Property Loss Notice. Damaged A/C units, the photo indicates cut electrical lines.

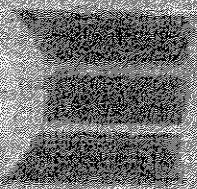
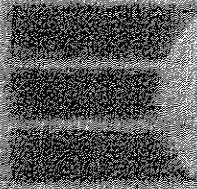
