GM Darlene,

We have received the above mentioned contract from the Department of Motor Vehicles. The attached service agreement will allow us to request and purchase motor vehicle records from the Department of Transportation. Commissioners Court approved the Scofflaw Interlocal Agreement with TxDOT 2 weeks ago. The Scofflaw Program will allow us to deny vehicle registrations to individuals that Hidalgo County identifies and submits to TxDOT.

One of the things that TxDOT requires us to submit to them in order to flag individuals it the Vehicle Identification Number. I am currently working with the IT department to establish a list of all persons that owe monies to the JP's that have License Plate Numbers. Once I gather this list, I will forward it to TxDOT and request that they match the License Plate number with the VIN. For those that match, we will forward to be flagged.

The attached Service Contact will allow us to "Probe" the data we have on Ableterm and forward our request for VIN from TxDOT. I am requesting that you please forward the attached file to Mr. Crain for "Legal Counsel to Review" and comment. We're hoping to place this item on the agenda next week and are respectfully requesting his review.
