**SUPPLEMENTAL AGREEMENT NO. 2
TO AGREEMENT FOR PROFESSIONAL SERVICES**

THIS SUPPLEMENTAL AGREEMENT is made pursuant to the terms and conditions of Article 8 of the Agreement made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner’s Court**, hereinafter called the “**Owner**”, and **Javier Hinojosa Engineering** Professional Engineers of, McAllen, Texas, hereinafter called the “**Engineer**”.

WITNESSETH

WHEREAS, the **Owner** and the **Engineer** executed the **Agreement** on the **28th** day of **October, 2008** concerning engineering for Preliminary, Design and Construction Phase Services for the Texas Department of Transportation Border Colonia Access Funded Colonias for Hidalgo County Precinct Number **3** (hereinafter referred to as the “**Project**”); and,

WHEREAS, Supplemental Agreement No. 1 to Work Authorization No. 1 Attachment “A” established that the Estimated Cost is \$311,597.70; and establishes the projects to be designed,

WHEREAS, it has become necessary to amend the Agreement to add projects resulting in an increased estimated amount.

A. AGREEMENT

NOW THEREFORE, premises considered, the **Owner** and the **Engineer** agree that said **Agreement** is amended as follows:

- I.** The Estimated Cost is revised to **\$336,020.16**.
- II.** Attachment “A” Revised (Listing of Colonias) is revised and made part of this agreement as attached.

All other provisions are unchanged and remain in full force and effect.
