We, the undersigned County Judge and County Clerk of **HIDALGO COUNTY, TEXAS** (the "*County*"), hereby certify as follows:

1. This certificate is executed with reference to that series of Bonds styled **CITY OF EDINBURG, TEXAS LOCAL GOVERNMENT FINANCE CORPORATION CONTRACT REVENUE BONDS, SERIES 2011**, issued in the aggregate sum of **\$4,275,000** (the "*Bonds*").

2. The County duly authorized the execution and delivery of the following documents related to the Bonds (the "*County Documents*")

- (i) Economic Development Agreement, dated as of February 20, 2007, among the City of Edinburg, Texas, the County, the Edinburg Economic Development Corporation, the City of Edinburg, Texas Local Government Finance Corporation, and First Hartford Realty Corporation, a Delaware corporation (as amended by a First Amendment, dated as of August 16, 2011, and by a Second Amendment, dated as of November 15, 2011); and
- (ii) Interlocal Agreement, dated as of November 8, 2011, between the County and the City of Edinburg, Texas.

The undersigned do hereby certify that attached hereto as Exhibit "A" are true, correct and complete copies of each of the County Documents.

3. The County is not in default as to any covenant, condition or obligation in connection with the County Documents.

4. No litigation is pending against the County or, to the best of our knowledge, threatened against the County:

- (i) to restrain or enjoin the execution, performance or delivery of the County Documents; or
- (ii) in any way contesting (a) the right and power of the County in connection with any action taken by it towards the execution, performance or delivery of the County Documents or (b) the title or authority of the current officers of the County to their respective offices.

5. This Certificate is submitted pursuant to 1 TAC § 53.246. Upon the Attorney General's approval of the Bonds, he is authorized to date this Certificate as of the date of such approval. If any litigation should develop, or if any other event should occur which should make this Certificate inaccurate before the Attorney General's approval of the Bonds, we will notify the Attorney General at once by both telephone and telecopy. With this assurance, the Attorney General is entitled to rely on the accuracy of this Certificate at the time of approval of the Bonds unless we advise him otherwise.
