Attached please find information regarding the award of the above-referenced 3rd Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid on the following:

Hinojosa Engineering, Inc has reviewed bids and tabulations and is recommending Saenz Utility Contractors of Edcouch, TX as the low bidder for the above-referenced project. The amount budgeted for roads is \$106,500.00 and budgeted for drainage is \$71,717.00 for a total amount of \$178,217.00. Based on the low bid amounts, roadwork and drainage will both have underruns. The county anticipates lapse funds for both roadwork and drainage.

The award will be to the low bidder Saenz Utility Contractors with a low bid amount of \$111,443.25.


