**SUPPLEMENTAL AGREEMENT NO. 2
TO AGREEMENT FOR PROFESSIONAL SERVICES**

THIS SUPPLEMENTAL AGREEMENT is made pursuant to the terms and conditions of Article 8 of the Agreement made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner’s Court**, hereinafter called the “**Owner**”, and **R. Gutierrez Engineering** Professional Engineers of, Pharr, Texas, hereinafter called the “**Engineer**”.

WITNESSETH

WHEREAS, the **Owner** and the **Engineer** executed the **Agreement** on the **28th** day of **October, 2008** concerning engineering for Preliminary, Design and Construction Phase Services for the Texas Department of Transportation Border Colonia Access Funded Colonias for Hidalgo County Precinct Number **2** (hereinafter referred to as the “**Project**”); and,

WHEREAS, it has become necessary to amend the Agreement to add projects resulting in an increased estimated amount.

A. AGREEMENT

NOW THEREFORE, premises considered, the **Owner** and the **Engineer** agree that said **Agreement** is amended as follows:

- I.** The Estimated Cost is revised to **\$83,379.81**.
- II.** “Attachment A” (Estimate Distribution) is made part of this agreement as attached.

All other provisions are unchanged and remain in full force and effect.
