 TO AGREEMENT FOR PROFESSIONAL SERVICES

**WHEREAS**, Amendment, establishes that the Estimated Cost is **\$41,298.57**; and establishes the projects to be designed,

**WHEREAS**, it has become necessary to amend the Agreement to add projects resulting in an increased estimated amount.

**A.    AGREEMENT**


**NOW THEREFORE**, premises considered, the **Owner** and the **Engineer** agree that said **Agreement** is amended as follows:
