**AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT
BETWEEN HIDALGO COUNTY AND CITY OF MERCEDES, TEXAS**

This **AMENDMENT** to the INTERLOCAL is made this 31st day of January, 2012 by and between **HIDALGO COUNTY, TEXAS** (the "COUNTY") and **CITY OF MERCEDES, TEXAS**, (the "CITY").

WHEREAS, City and County entered into an Interlocal Agreement dated October 18, 2011 for Hidalgo County and City Of Mercedes to assist each other in multiple projects to be defined by mutual agreement in which both the City and the County would benefit from the outcome of the work (the "work");

WHEREAS, County shall provide City with man power at the current hourly rates for individuals required to complete the work.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, City and County hereby agree to the following amendment to the Agreement:

1. Exhibit "A" under current Interlocal Agreement shall be deleted in its entirety and Exhibit "A" attached hereto shall be substituted in lieu thereof:
2. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and City and County ratify and confirm the terms and provisions of the Agreement as amended.
