In compliance with Community Development Block Grant (CDBG) requirements, the Hidalgo County City of Alamo will conduct a Public Hearing to solicit input from interested parties on the City's proposed budget & program amendment to its Urban County Program Year 23 (2010).

The Public Hearing will be held on Tuesday, January 17, 2012 at 7:00PM at the Alamo City Hall Office located at 420 North Tower Road, Alamo, Texas 78516.

The proposed amendment will include a **Transfer of surplus funds** from the Street Improvements line item into the Fire Station Equipment line item for the continuation of funding for the 2011 Fire Station Equipment bond Payment due on February 2012 and August 2012., Surplus funds in the amount of \$58,581.82 will remain in the street improvements line item, but will include a new project to the 2010 fiscal year. The new project includes the Purchase and installation of solar lights at Duranta Ave. and Main Street, an already approved 2009 project.
