Once the Door was opened the suspect(s) took an Assortment of tools and equipment. A list of all Items is included into this report. Deputy Sheriff R.J. Garcia was also on scene to take a report. Joe Diaz advised me that Jose Velasquez was inside the Pavilion Yesterday looking around at the equipment. Velasquez is an ex-employee of Pct.#1.
