Attached is a quote for a file sharing service that gives us the option to upload and download files and reports via the web. We are needing this option since we have been restricted by the county IT department from using USB and CD drives on all the computers. We have setup a temporary 15-day trial to test and so far we have had great success uploading the TIRZ reports and having each city jurisdiction download them, rather than emailing, which is also difficult since we are limited to only 5 MB file attachments.
