**AMENDMENT TO CONTRACT C-12-008A-03-20
FOR PRINTING SERVICES AND RELATED SUPPLIES**

This **AMENDMENT** to the **CONTRACT** is made this 8th day of May, 2012 by and between **HIDALGO COUNTY, TEXAS** (the "COUNTY") and **COPY IT INC., A TEXAS CORPORATION**, ("COMPANY").

WHEREAS, Company and County entered into a Contract dated March 20, 2012 for Hidalgo County's Printing Services And Related Supplies on an as needed basis;

WHEREAS, Company agrees to provide the Services to locations specified by Hidalgo County by third party insured shippers FOB such locations so specified by Hidalgo County;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. Numbered paragraph 1 of the Contract is deleted in its entirety and the following is substituted in lieu thereof;

County and Company hereby agree that this Contract is entered into in order to provide the Services to locations at Hidalgo County by third party carriers. This Contract does not extend to any third parties any duties or benefits conferred in any manner hereunder or otherwise.

2. Numbered paragraph 2 of the Contract is deleted in its entirety and the following is substituted in lieu thereof;

Company hereby promises and agrees to render and provide, during the term of this Contract, and shall be obligated to render and provide the Services in accordance with Specifications of Hidalgo County following a request for Services by the Commissioners' Court or their designated agent. Company agrees n performing the Services that it will use proper professional standards, comply with any and all appropriate laws and regulations in providing the Services. Company shall provide the Services to locations specified by Hidalgo County by third party insured shippers FOB such locations so specified by Hidalgo County.

3. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms

and provisions of the Contract as amended.

Attached for legal's review as to form of the amendment in connection to the above referenced contract which has not been executed inasmuch as the document has been approved by legal and Commissioners Court however, as per legal, the contract would not be signed until the insurances were provided by the company being that the company had selected that they would provide the insurances pursuant to the ten working day notice of award.

The insurance was provided in the certificate of accord but only the general liability since the vendor stated and submitted that they deliver by a third party courier (see vendor's notification as attached as last page of the contract).

As I mentioned to you that an amendment to the contract would now be required to include language in the contract so as to allow the delivery of services/products by a third party courier. We currently have in place one or two contracts that allows this.

I need for legal to review draft amendment, the contract including the vendor's insurance so as to proceed ahead with an agenda item for approval of the amendment.
