Attached please find information regarding the award of the above-referenced 3rd Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid on the following:

1. Engineer's Recommendation
2. Bidder meets all County requirements
3. Bids is the lowest of bids received
4. Cost breakdown

TEDSI Infrastructure Group has reviewed bids and tabulations and is recommending Asago, LLC d/b/a Asago Construction of Mission, TX as the low bidder for the above-referenced project. The amount budgeted for roads is \$213,250.95 and budgeted for drainage is \$21,600.00 for a total amount of \$234,850.95. Based on the low bid amount, roadwork has an underrun and drainage will has a substantial overrun. The additional funds that will cover the overrun will be lapse funds from completed projects. Currently and based on TXDOT spreadsheet BCAP3_Hidalgo_030712 the remaining balances for this project are \$21,600.00 for drainage and \$183,347.51 for road work.

The award will be to the low bidder Asago, LLC d/b/a Asago Construction with a low bid amount of \$317,767.00.


