Javier Hinojosa Engineering has reviewed bids and tabulations and is recommending GP7 Construction, LLC of Brownsville, TX as the low bidder for the above-referenced project. The amount budgeted for roads is \$118,470.73 and budgeted for drainage is \$100,635.00 for a total amount of \$219,105.73. Based on the low bid amounts, roadwork and drainage will both have underruns. The county anticipates lapse funds for both roadwork and drainage.

The award will be to the low bidder GP7 Construction, LLC with a low bid amount of \$163,402.20.
