Attached please find information regarding the award of the above-referenced 3<sup>rd</sup> Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid on the following:

1. Engineer's Recommendation
2. Bidder meets all County requirements
3. Bids is the lowest of bids received
4. Cost breakdown

DOS Logistics, Inc. has reviewed bids and tabulations and is recommending 2GS, LLC of Peñitas, TX as the low bidder for the above-referenced project. This project was not completed initially by the then awarded low bidder (Total Commitment, LLC) and the Performance Bond company refused to complete the project; therefore, the County will be completing the project with the BCAP remaining balances plus any additional funds needed due to overruns. The County has filed suit against the bonding in order to recover and additional County funds use to complete the project. Presently the available BCAP funds are \$17,365.04 for roadwork and \$21,860.53 for drainage. The total amount from both fund sources is \$39,225.57. Based on the low bid amounts, drainage should be covered with the available BCAP funds.

The award will be to the low bidder 2GS, LLC with a low bid amount of \$80,125.00.
