Thanking you for your assistance in this matter, I remain.

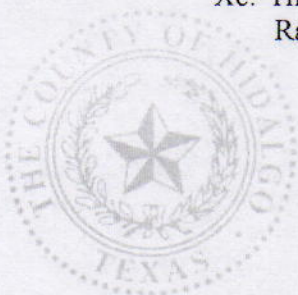

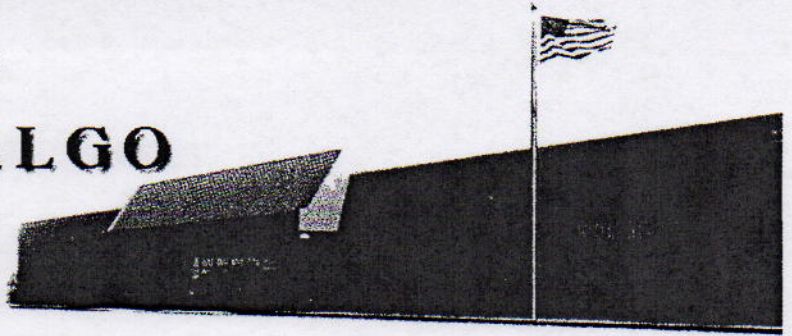


